Originally proposed as a 'user pays' project, the site will now be fully maintained by East Gippsland Shire Council. Operational costs have recently been estimated at \$270,000 annually - money to be collected from all shire ratepayers of course.

At a loss

Sir, - I am at a loss to understand the claims made by Mr Rudge (Snowy River Mail, February 13), apparently representing the Mallacoota Business Tourism Association, and echoed by Charles Davidson (Snowy River Mail, February 20), about the merits of East Gippsland Shire's proposal to build a breakwater at Bastion Point with an access road on the beach.

Both men claim the proposed development will enhance safety by separating boating away from other activities, and restore the family beach to its original condition.

Yet a submission to the panel of inquiry into the en-

vironmental effects of the Ocean Access Boat Ramp at Bastion Point (28 June 2008) by the Mallacoota Ocean Access Committee, of which Mr Rudge was then vice-chair, argued against constructing a road on the beach. Their reason?

"It... would compromise public safety, as it would result in continuing conflict between boat operators and other Bastion Point users... reduce visual amenity and (be) inconsistent with the proposal to restore the beach at the existing site". A further point omitted by both Mr Rudge and Mr Davidson is that this "family beach" is also the proposed site for dumping sludge from the continual dredging which will be necessary to maintain the new boat ramp in a state fit for use.

Is this part of their vision for restoring the beach? The cost of the dredging will, of course, be carried by us, the ratepayers of East Gippsland Shire.
